2.2. Presentations

2.2.1. Kayode Akomolafe – Student Demographic Survey

Kayode Akomolafe, Human Rights and Equity Advisor, presented the Board's plan for conducting the 2023-2024 Student Demographic Survey:

- Under the Ontario Human Rights Code, the Board has a responsibility to promote a safe, welcoming, and inclusive environment.
- The Anti-Racism Act provides a framework to identify and eliminate systemic racism and advance racial equity.
- *The Act* requires the Education sector to collect demographic data and response rates.
- The Board conducted a student census in 2021-2022. The 2023-2024 survey builds on the 2021-2022 consultation and has implemented lessons learned from the first census.

Student Demographic Survey:

- A voluntary survey offering students the opportunity to share their identities, culture, race, ethnicities, genders, abilities, and countries of origin. Resulting data will be further disaggregated to better understand the student experience (i.e. graduation rates, enrolment, suspension/expulsion rates, etc.)
- Survey will take place between April 22-26, 2024.
- Parents will complete the survey for students in Grades K-8. Students in Grades 9-12 will complete the survey in class.
- K-8 Parents/guardians/caregivers and 9-12 students will receive a unique, confidential link to their email on file.

Informed by the Ministry of Education's Equity Action Plan and the Anti-Racism Act, the goals are to:

- Understand and support the diversity of students and families.
- Identify and eliminate barriers to student success, engagement and well-being.
- Improve student achievement.
- Enrich students' learning by providing the right supports at the right time.
- Ensure our schools are safe, welcoming and accepting spaces.
- Know and understand our students, so we can better respond and support them.

Important Matters:

- <u>Survey webpage</u>: Information about the survey, preview the questions, FAQs, and 2021-2022 student census results.
- Action Requested: Administrators to ensure compliance with the process of completing the survey.



• Initial communication regarding the survey will include a link for families to opt out of the survey entirely. Within the survey, there will also be the option to opt out of questions.

Completion rate for the 2021-2022 student census was 39 per cent. The Ministry shared that the Board had one of the highest completions rates in the province. Additionally, the data from the census showed that completion rates reduced as the Grade of the student increased. For the 2023-2024 survey, the Board is ensuring more time for students to complete the survey.

Next Steps:

- Public report on data obtained through the Student Demographic Survey to be available on Board website.
- Disaggregated data from survey to be used to inform evidence-based decisions to support students at every level (i.e. pedagogy, programs, policies, services, etc.)
- Ongoing additions to be made to the public report to illustrate how data obtained from the survey is being used to inform plans, programs, resources/supports, etc.

2.2.2. Marie Hammond – Budget Consultation

Marie Hammond, Chief Financial Officer, presented the 2024-2025 Budget Consultation through ThoughtExchange:

- The Board is seeking input on their school goals and budget planning.
- The consultations will ask about what the Board is currently doing well and how they can improve.
- Consultation will help the Board to set goals for our schools in the 2024-2025 school year.
- The Board has 3 strategic priorities that they would like to get input from the public on: Supporting Faith and Well-Being, Advancing Human Rights and Equity, and Improving Student Learning.
- The consultation will use the same question as the previous year to compare results.
- ThoughtExchange is currently open and available until Friday, March 22, 2024.

2.5. Staff Reports

2.5.1. Student Services Report – Christine Congrady, Yulan Fisher-Brown, Paula Sorhaitz

Christine Congrady presented the Coordinator's Report:

Behaviour Management Systems (BMS) Training:

- On Feb. 8, 15 and 23, BMS training was offered through a Sharing of Excellence by Tammy Fleming, from the Behaviour Resource Team (BRT).
- The first two sessions were presented online via Teams and focused on theory. The final session was a review of theory, physicals and final assessment and offered in person at Paul Dwyer Learning Commons. Five participants successfully completed the certification.

Students with Assistive Technology Transition Trips (SWATTT):

- SWATTT hosted by the 7 secondary schools were completed as of March 4.
- 150 students from DCDSB's elementary schools attended the trips at their feeder schools.
- The trips were supported by Assistive Technology Specialists (ATSs) and AT Technician, elementary and secondary Program Support Teachers (PSTs), Intermediate Guidance Teachers (IGTs) and Student Services Consultants.

Project SEARCH:

- February 28, 2024 Project SEARCH Parent/Guardian Information Session.
- It was a hybrid event with approximately 50 people in attendance.
- Highlight of the evening occurred when current interns shared their experiences with the program and parents gave testimonials.

- March 21 is World Down Syndrome Awareness Day
- A numbered memo with information and resources for educators was sent out to the system on March 5

Yulan Fisher-Brown presented the Mental Health Report: DCDSB Let's Talk Day:

- March 19, 2024 This day will be dedicated to ensuring that all students know where to go at school in order to access help with their mental health.
- Lessons/activities have been curated for all grades and secondary for educators to share with students.
- All secondary students will receive a locker magnet, and Grades 6-8 will receive a whiteboard.



Black Mental Health Day:
