- 1. Is the overall design of the study well thought through?
- 2. Are the qualitative or quantitative approaches being used appropriate in the study?
- 3. Does it follow acceptable research procedures and methods of statistical analysis?
- 4. Are the theory and research questions clear and presented in plain language? Are the questions likely to be answered by the methodological design?
- 5. Are the instruments being used adequate and appropriate? Are instructions to participants clear?
- 6. Does the proposal provide enough information for the Committee to identify the main ideas to be included in the survey, interview, observation, etc.? This point is of particular importance in qualitative research. There should be enough information to provide the Committee with a reasonable description of the researcher's intent and procedures. The underlying theory should be clear and, at the least, headings provided for questions which are going to be asked.
 - Are key questions specified?
 - Are the key questions anchored in theory?
 - Are they well phrased?
 - Are they related to the purpose?
 - Are copies of all materials to be used in the study included with the application?
- 7. Are there clear procedures for sample section?
